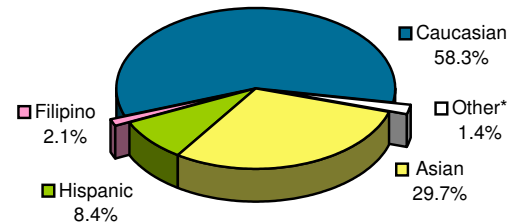


### Community & School Profile

Situated on the eastern border of the San Fernando Valley at the base of the Verdugo Mountains, the city of Glendale is the third largest city in all of Los Angeles County. Glendale Unified School District serves more than 28,000 students on both year-round and traditional calendar systems. Comprised of 20 elementary schools, four middle schools, five high schools, and two specialized schools, the district offers a variety of creative programs that provide Glendale parents and students with many options for fulfilling individual needs and goals.

Located in La Crescenta, Crescenta Valley High School tailors its educational programs to meet the needs of an ever-changing population. The school serves students from the La Crescenta, Montrose, northern Glendale, and La Canada Flintridge areas. During the 2005-06 school year, Crescenta Valley High School served 2,905 ninth through twelfth grade students on a traditional calendar schedule. The 2005-06 student population consisted of 6.9% 'Socioeconomically Disadvantaged,' 7.5% 'English Learners,' and 7.1% 'Students with Disabilities.' ### Discipline & Climate for Learning

Students at Crescenta Valley High School are guided by specific rules and classroom expectations that promote respect, cooperation, courtesy, and acceptance of others. The goal of Crescenta Valley High School's discipline program is to provide students with opportunities to learn self-discipline through guidelines that entail consistent rewards and consequences for individual behavior. Parents and students are informed of discipline policies at the beginning of each school year through classroom orientation and individual parent/student information packets.

In addition to sponsoring programs that eliminate bullying, bolster conflict resolution, and promote peaceful interactions on campus, the school utilizes Clay Roberts' 40 Developmental Assets.

These assets, incorporated within and outside the classroom, have been identified as strengths necessary for the healthy development of today's youths.

The Suspensions and Expulsions table below illustrates total cases for the school and district at all grade levels, as well as the percentage of total enrollment. Suspensions are expressed in terms of total infractions, not total number of students, as some students may have been suspended on several occasions. Expulsions occur only when required by law or when all other alternatives have been exhausted.

To build self-esteem and recognize student achievement, certificates, ribbons, prizes, and various other awards are given to students at assemblies and special presentations throughout the school year. ### School Leadership

Mr. Livingston has been at the school for four years and previously served as an Assistant Principal, Dean of Students, Coordinator of Attendance and Welfare, and classroom teacher.

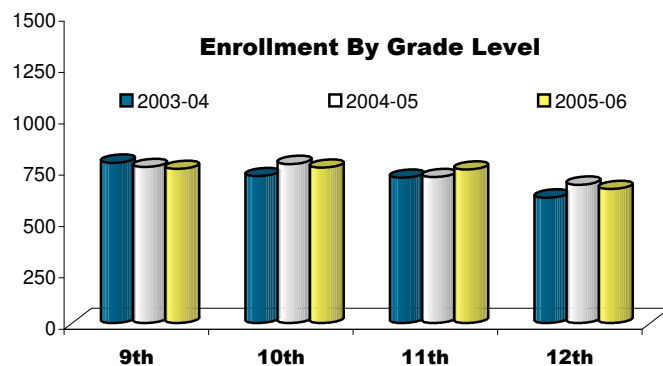

### Minimum Days & Instructional Minutes

During the 2005-06 school year, Crescenta Valley High School offered 180 days of instruction, comprised of 159 regular days, four minimum days, and 17 modified days. Minimum and modified days are scheduled for staff development, curriculum planning, and the last day of instruction. Students were offered 65,560 minutes of annual instructional time during the 2005-06 school year, exceeding the state requirement of 64,800 minutes at the high school level.

### School Enrollment & Attendance

School districts receive financial support from the state for the education of the students they serve based on how many students attend each day. Most importantly, attendance is critical to academic achievement. Student attendance is carefully monitored to identify those students exhibiting excessive absences. The following chart illustrates enrollment at Crescenta Valley High School over the past three years.



Attendance, tardy, and truancy policies are clearly stated, consistently enforced, and consequences are fairly administered. Parents are advised of their responsibilities, including proper notification of when and why students are absent. Staff members make daily phone calls to parents when children are absent. When a student has repeated tardies or unexcused absences a letter is mailed home, and a parent conference may be scheduled.

In the event of habitual truancy, students may be referred to the district's School Attendance Review Board (SARB). The SARB is utilized when students have persistent attendance and behavior problems in school, and when the normal avenues of classroom, school, and district counseling are not effective.

Intervention programs that promote attendance and reduce dropout rates include: tardy sweeps, counseling office domains, student conference, referral to the school psychologist, phone calls home, five-, ten-, and twenty-day letters, counseling, parent conference, student support services referral, appeals, and a five-step discipline plan.

## Work Force Preparation

Crescenta Valley High School places great emphasis on ensuring that students understand the importance of academic subjects and experience how employees apply subject learning to work situations. The school's programs focus on preparing students to think conceptually, communicate effectively, and apply skills in real-world contexts. Curriculum and instructional strategies that foster critical thinking, problem solving, leadership, and academic skills are consistently taught to the students to ensure work-readiness.

Crescenta Valley High School offers a variety of career-path related classes in the following career clusters: Air Force ROTC, Business Professional/Office, Design, Communication and Art, Digital Photography, Education, Food Industry, Graphic Arts, Health, Robotics, Science and Technical, Science/Medicine Academy, Social Science, and Stage Arts.

The school encourages students who are age 16 or older to participate in the diverse opportunities provided by Regional Occupational Program (ROP) classes through LA County. Students are able to attain Career Preparation credits toward graduation through ROP participation.

The school addresses the needs of all students, as well as those in career preparation, through guidance and counseling from school personnel regarding career paths and courses of study. Career Counselors expose students to a broad array of career opportunities and facilitate selection of a career path based on individual interests, goals, strengths, and abilities.



Additionally, the Verdugo School-to-Career Advisory Committee is a consortium of business leaders and educators who provide grants for work-related programs at local schools. Using surveys and evaluations, the district monitors the success of these programs and reports to the Verdugo School-to-Career Advisory board of directors.

## College Preparation

Crescenta Valley High School offers college-bound students many opportunities to get a head start on their future. College preparation activities and programs are part of the school curriculum, enhanced by supplemental programs sponsored by the school and Glendale Community College. The on-site College and Career Center hosts college admissions representatives, offers information about colleges, trade and technical schools, and provides students with occupational training programs.

The school's Advanced Placement program allows students to qualify for college credit. During the 2005-06 school year, college-level courses offered at CVHS included: History of Art, Studio Art, English Literature & Composition, Spanish Language, German Language, French Language, Calculus AB and BC, Statistics, General Biology, General Chemistry, Physics B, Environmental Science, Macroeconomics, European History, U.S. History, and Psychology.

Students at Crescenta Valley High School are encouraged to take College Preparatory courses if they plan to attend a four-year university. All students must pass each course with a grade of "C" or better each semester. Students are encouraged to apply to the University of California/California State University systems through the use of online applications. Crescenta Valley High School provides its computer labs and support staff to assist students during the submission process.

## Student Achievement & Testing

Various measures of student achievement are used as an ongoing part of the quality instructional program at Crescenta Valley High School. These assessments provide a measurement of students' actual progress and evaluate the effectiveness of instructional programs. In addition to the Standardized Testing and Reporting (STAR) program, the school and district administer other assessments to determine the progress of each student. High school students are evaluated based on the results of their writing, report card grades, and end-of-course exams each semester. Results of these assessments and state testing are evaluated annually to determine whether each student is performing below, at, or above grade-level standards.

## California Standards Test

The California Standards Test (CST), a component of the STAR Program, is administered to students in the spring to assess student performance in relation to the State Content Standards. Student scores are reported as performance levels: Advanced (exceeds state standards), Proficient (meets standards), Basic (approaching standards), Below Basic (below standards), and Far Below Basic (well below standards). The combined percentage of students scoring at the Proficient and Advanced levels in English/Language Arts and Social Science, for the most recent three-year period, is shown at right.

## California High School Exit Exam

Beginning with the graduating class of 2006, students in California public schools must pass both the English/Language Arts and Mathematics sections of the California High School Exit Examination (CAHSEE) to receive a high school diploma. For students who began the 2005-06 school year in the 12th grade, the table below displays the percent of students who successfully passed the CAHSEE. *Due to the state's collection schedule for high school completion data, state-level data for this reporting element will not be available for report cards published in the 2006-07 school year.*

## SAT Reasoning Test

Each year, students have the opportunity to participate in SAT testing. This instrument is designed to assess many of the skills that are important to a student's success in college and their general educational development. Students may take the test more than once, but only the highest score is reported at the year of graduation.

SAT Preparation workshops are available to all students after school and on Saturdays. All workshops are free or available for a nominal fee.

## Physical Fitness

In the spring of each year, Crescenta Valley High School is required by the state to administer a physical fitness test to all ninth grade students.

The physical fitness test measures each student's ability to perform fitness tasks in six major areas: Aerobic Capacity, Body Composition, Abdominal Strength, Trunk Extension Strength, Upper Body Strength, and Flexibility. Students who either meet or exceed the standards in all six fitness areas are considered to be physically fit or in the 'healthy fitness zone' (HFZ). During the 2005-06 school year, 57.8% of Crescenta Valley High School's ninth grade students met or exceeded state fitness standards.

## Adequate Yearly Progress

No Child Left Behind (NCLB) is a federal law enacted in January 2002 that reauthorized the Elementary and Secondary Education Act (ESEA). It mandates that all students (including students who are economically disadvantaged, are from racial or ethnic minority groups, have disabilities, or have limited English proficiency) in all grades meet the state academic achievement standards for Mathematics and English/Language Arts by 2014. Schools must demonstrate "Adequate Yearly Progress" (AYP) toward achieving that goal. Schools must demonstrate "Adequate Yearly Progress" (AYP) toward achieving that goal. The federal NCLB Act requires that all schools and districts meet the following Adequate Yearly Progress (AYP) requirements:

- Participation rate on the state's standards-based assessments in English/Language Arts (ELA) and Math.
- Percent proficient on the state's standards-based assessments in ELA and Math.
- API as an additional indicator.
- Graduation rate (for secondary schools).

There are several consequences for schools that do not meet the AYP standards, including additional tutoring and replacing of staff. Students would also be allowed to transfer to schools (within their district) that have met their AYP's, and the former school would be required to provide the transportation to the new site.

Results of school and district performance are displayed at right. Crescenta Valley High School met all of the 2006 AYP criteria.



## Academic Performance Index

The Academic Performance Index (API) is an annual measure of the academic performance and progress of schools in California. API scores range from 200 to 1,000, with a statewide target of 800.

**Statewide API Rank:** The statewide API rank ranges from 1 to 10. A statewide rank of '1' means that the school has an API score in the lowest 10 percent of all schools in the state, while a statewide rank of '10' means that the school has an API score in the highest 10 percent of all schools in the state.

**Similar Schools API Rank:** The similar schools API rank reflects how a school compares to 100 statistically matched "similar schools." A similar schools rank of '1' means that the school's academic performance is comparable to the lowest performing 10 schools of the 100 similar schools, while a similar schools rank of '10' means that the school's academic performance is better than at least 90 of the 100 similar schools.

## Federal Intervention Program

Schools and districts receiving federal Title I funding enter Program Improvement (PI) if they do not make AYP for two consecutive years in the same content area (English/Language Arts or Mathematics) or on the same indicator (API or graduation rate). After entering PI, schools and districts advance to the next level of intervention with each additional year that they do not make AYP.



## School Facilities & Safety

Crescenta Valley High School, originally constructed in 1946, is currently situated on 18 acres and comprised of 110 classrooms, a library, three computer labs, two gymnasiums, an auditorium, a cafeteria, a pool, basketball, handball, and tennis courts, field facilities, and administrative offices. A \$45 million renovation and renewal project, funded through Measure K, was completed in 2001. Students and staff now benefit from two new classroom buildings, a library-career-media-center, an additional gymnasium, as well as extensive upgrades to all existing classrooms and landscaping. The track and field have been renovated thanks to contributions from CVCAN, a local committee focusing on improving athletic needs, and Susan Osborne, a generous donor.

Safety of students and staff is a primary concern of Crescenta Valley High School. Administrators, teachers, security agents, and resource officers from Los Angeles County Sheriff's Department monitor students at breaks, lunch, and before and after school. While the school welcomes visits by parents and community members, anyone wishing to be on campus during school hours must notify school staff in advance. All visitors to the campus must report to the front office, sign in, and obtain a visitor's pass which must be displayed at all times.

The School Site Safety Plan is evaluated and revised each spring by members of the Site Safety Committee; all revisions are shared immediately with staff members. Key elements of the plan include: child abuse reporting procedures, teacher notification of dangerous pupils procedures, disaster response procedures, procedures for safe ingress and egress from school, sexual harassment policy, and dress code policy.

The school is always in compliance with the laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. Fire, lockdown, and earthquake drills are conducted on a regular basis throughout the school year. The following chart displays the results of the most recent school facilities inspection, completed on October 24, 2006.

### Cleaning Process

Crescenta Valley High School provides a safe and clean environment for students, staff, and volunteers. The district governing board has adopted cleaning standards for all schools in the district. Basic cleaning operations are performed on a daily basis throughout the school year with emphasis on classrooms and restrooms. A joint effort between students and staff helps keep the campus clean and litter-free. The Principal works daily with the custodial staff to develop sanitation schedules that ensure a clean, safe, and functional learning environment.

### Maintenance & Repair

A scheduled maintenance program is administered by Crescenta Valley High School's custodial staff on a regular basis, with heavy maintenance functions occurring during vacation periods. Additionally, a scheduled maintenance program is administered by Glendale Unified School District to ensure that school grounds and facilities remain in excellent repair. A work order process is used when issues arise that require immediate attention. Emergency repairs are given the highest priority; repair requests are completed efficiently and in the order in which they are received.

### Deferred Maintenance Budget

The State School Deferred Maintenance Budget Program provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems.

For the 2006-07 school year, Glendale Unified School District has budgeted \$1,238,000 for the deferred maintenance program, which represents 0.57% of the district's general fund budget. As part of a five-year plan, Crescenta Valley High School is scheduled to receive asbestos abatement, plumbing upgrades, new floor covering, HVAC and boiler replacements, window, door, and wall replacements, asphalt sealcoating, roofing repairs, and exterior painting between 2006 and 2010.

### Counseling & Other Support Services

In addition to academics, the staff at Crescenta Valley High School strives to assist students in their social and personal development. Staff members are trained to recognize at-risk behavior in all students. The school values the importance of on-site counseling and has procedures in place to ensure that students receive the services they need. Psychologists and counselors are devoted to helping students deal with problems and assisting them to reach positive goals. The following chart displays a list of support services that are offered to students at the school.

Students with special needs are provided support through the district's Special Education Program and ten on-site Special Day Class (SDC) teachers. Each identified student is evaluated by a team consisting of his/her parent(s), a teacher specialist, school administrators, and the psychologist in order to develop an Individual Education Plan (IEP). The IEP defines the individualized instruction a special needs student will receive. Instruction is provided in the least restrictive environment possible and students are mainstreamed whenever appropriate.

All teachers at Crescenta Valley High School are appropriately credentialed and able to instruct students acquiring English as a second language. English Learners (EL) receive core instruction in all content areas daily, including leveled English Language Development (ELD). EL students are tested with the California English Language Development Test (CELDT) annually to measure progress.

Crescenta Valley High School has two special programs to assist at-risk students including the Individualized Education Program and a special study skills support course.

The Gifted and Talented Education (GATE) program is offered to students in grades nine through twelve who have been recognized as capable of attaining high levels of achievement. Students are identified based on teacher recommendations and individual performance on state tests. Crescenta Valley High School provides advanced placement courses and special activities for GATE students.



The district participates in the state's Healthy Start, Healthy Families and Healthy Kids programs. These programs are coordinated through the Healthy Start and Family Resource Center at the Pacific Avenue Education Center (440 West Lomita; Glendale, CA 91204), and serve qualifying students and their families throughout the district, providing medical and nutrition services along with a variety of other assistance and referrals. The Healthy Start and Family Resource Center also administers Project Access to Education (PACE), assisting homeless families to enroll their children in school, overcome obstacles that might keep their child from attending school, and allow their child to stay in one school while the family transitions into a more stable environment.

## Teacher Assignment

Glendale Unified School District recruits and employs only the most qualified credentialed teachers. During the 2005-06 school year, Crescenta Valley High School staffed 110 fully certificated teachers who met all credential requirements in accordance with the State of California guidelines.

The Federal No Child Left Behind Act requires that all teachers in core subject areas meet certain requirements in order to be considered as "Highly Qualified" no later than the end of the 2005-06 school year. Minimum qualifications include: possession of a Bachelor's Degree, possession of an appropriate California teaching credential, and demonstrated competence in core academic subjects.

## Substitute Teachers

Substitute teachers must hold a bachelor's degree and have successfully passed the California Basic Educational Skills Test (CBEST). Prior to a substitute's first assignment in the district, he/she attends a three-hour training session on district policies and expectations.

A pool of over 300 qualified substitutes is available to Glendale's schools and the district has not yet experienced any difficulties providing qualified substitute teachers. On rare occasions when a substitute is not available for an absent teacher, credentialed staff or administrators will assume the role of the substitute.

## Teacher Evaluation & Professional Development

A constructive evaluation process promotes quality instruction and is a fundamental element in a sound educational program. Evaluations and formal observations are designed to encourage common goals and to comply with the state's evaluation criteria and district policies. Temporary and probationary teachers are evaluated twice a year and tenured teachers are evaluated every other year. Evaluations are conducted by the co-principals, who have been trained and certified for competency to perform teacher evaluations.

Evaluations are based on the California Standards for the Teaching Profession, which include:

- Engaging and Supporting all Students in Learning
- Understanding and Organizing Subject Matter for Student Learning
- Assessing Student Learning
- Creating and Maintaining Effective Environments for Student Learning
- Planning Instruction and Designing Learning Experiences for all Students
- Developing as a Professional Educator

Staff members build teaching skills and concepts through participation in conferences and workshops throughout the year. For the past three years, the district has sponsored two staff development days annually where teachers are offered a broad-based variety of professional growth opportunities in curriculum, teaching strategies, and methodologies. During the 2005-06 school year, staff development topics at Crescenta Valley High School included:

- AP Training
- Writing Across the Curriculum
- Powerful Instructional Strategies
- Reading & Literacy
- Student Achievement

For additional support in their profession, teachers may enlist the services of the district's Peer Assistance and Review (PAR) program, and/or the Beginning Teacher Support and Assessment (BTSA) facilitator. The Paraprofessional Teacher Training Program (PTTP) is also available, offering assistance to educational assistants interested in pursuing a teaching career.

## Curriculum Improvement

Crescenta Valley High School's curriculum is written in compliance with the state framework and the model curriculum standards dictated by the State Department of Education. The District Curriculum Committee is the primary leadership team responsible for monitoring and evaluating the curriculum. Decisions concerning curriculum improvement are then made through a collaborative effort among school representatives, ensuring that all changes are schoolwide, not isolated to a single class or grade level.

## Textbooks & Instructional Materials

Pursuant to the settlement of Williams vs. the State of California, Glendale Unified School District thoroughly inspected each of its school sites at the beginning of the 2006-07 school year to determine whether or not each school had sufficient and good quality textbooks, instructional materials, and/or science laboratory equipment. All students, including English Learners, are required to be given their own individual textbooks and/or instructional materials (in core subjects), for use in the classroom and to take home if necessary. Additionally, all textbooks and instructional materials used within the District must be aligned with the California State Content Standards and Frameworks, with final approval by the Board of Education.

Science Laboratory Equipment: CVHS stocks an adequate supply of laboratory equipment for its students. Inventory includes, but is not limited to: microscopes, slides, ring stands, clamps, support rings, utility clamps, test tubes, test tube holders, test tube brushes, crucible tongs, flasks, beakers, and bunsen burners. The school's fully automated library, staffed by a full-time librarian, is stocked with thousands of books that are available for students to check out. Students visit the library on a weekly basis with their classes and are encouraged to visit on breaks and before and after school. A 30-workstation lab is located within the library so students are able to access resources and information online.

Computer skills and concepts prepare students for technological growth and opportunities. Each classroom at Crescenta Valley High School contains a minimum of one computer. In addition to numerous mobile carts, students also have access to two computer labs on campus, each containing between 15 and 20 Internet-accessible workstations. Students receive computer-assisted instruction on a regular schedule.
